#### PREAMBLE

The Justice Must Prevail Party (JMPP) holds the believe that the Almighty created Nigeria to be a Big Brother and rallying point for all blacks on earth. For that purpose, He endowed Nigeria with super-abundant resources, which will enable her to develop to a super-power among Nations, thereby raising the respect, prestige and dignity of black persons and ultimately, wiping away the shame of slavery from the faces of all blacks.

JMPP further believes that Nigeria has deviated from the purpose for which she was founded. She has, through monumental corruption, which have eaten deep into every fabric and facet of her Institutional and Social Structures, failed comprehensively and woefully. **In today's Nigeria there is no justice, no fairness, no equity and our Country is therefore threatened with collapse and disintegration.** 

JMPP accepts that Nigeria has failed, and has no basis for continued existence, except as a changed Country. Corruption must be exterminated from our land. There must be institutionalized restoration for zero tolerance for corruption and strict compliance to the appropriate Oaths of Office in this Country. **To re-make Nigeria is a task that we must accept and do. JMPP logically believes in restructuring of the country to go back to that structure of Nigeria agreed by our heroes past – a structure that shall be truly federal with fiscal federalism; that must answer to the yearnings of the citizens for justice for all in all aspects of governance and development; and, that would ensure the restoration of peaceful coexistence and national unity.** 

#### **TECHNICAL METHODOLOGY**

It is a Party of Covenant, where, He will gather the righteous in this nation, those that made covenant with Him by Sacrifice of Oath, for the purpose of ensuring that His righteousness prevails upon the Nation, which is special in creation as a leader in Africa, and He, the Almighty, being the judge Himself.

JMPP is open to all Nigerians of Eighteen (18) Years and above. JMPP hopes to replace the existing dispensation of corruption, tribalism, nepotism, egocentrism, injustice, lawlessness, insecurity, armed robbery, kidnapping, assassination, political thuggery, ritual killings, poverty, hunger, disease, exploitation, inequality, unemployment, illiteracy, underdevelopment among other primordial forces with justice, equitable, egalitarian, democratic, accountable and transparent society where every citizen is giving a sense of belonging.

#### Q WOMEN AND NATIONAL GENDER POLICY

To substantiate JMPP's Manifesto and Constitutional A p plication in governance of 35-50 plus Manifesto/Constitution, JMPP shall note and apply National Gender Policy according to the Federal Republic of Nigeria. #### MISSION

A Nigeria where every citizen becomes his and her neighbour's keeper, in the fear of God for goodwill and love for fellow citizens.

To this end, the Justice Must Prevail Party (JMPP) shall democratically evolve Policies, Programs and Projects in compliance with the provisions of the Country's Constitution to ensure the rapid growth and development of the National wealth and its judicious distribution to ensure the common good of all. JMPP's goal, is to promote the common good by popular participation, banish poverty, illiteracy, joblessness and, while protecting the environment, ensure the rapid industrialization of Nigeria and the happiness of all citizens.

#### STRATEGIC FRAMEWORK

In order to realize the above Vision, Mission and Goals, **and place Nigeria in a better stead within the International Comity of Nations,** JMPP will pursue the following objectives:

- 1 Package and market JMPP to Nigerians as a veritable and credible Political Association **with human conscience** capable of providing **acceptable** leadership by offering accountable and transparent governance for the Country.
- 2 Attract, mobilize and retain credible, patriotic, creative and Visionary Nigerians who desire transformative change and sustainable development for Nigerians.
- **3** Identify, train and sponsor creative, patriotic and Nationalistic Nigerians for all Elections in the Country.
- 4 Participate in and win elections and form Governments at the Local, State and National Levels.
- 5 Conceptualize and develop, projects that promote JMPP before Nigerians as a serious, Committed and credible political party capable of providing a responsible and healthier Government for the Country.
- 6 Mobilize and educate Nigerians on democratic governance and their civic responsibilities.
- 7 Provide a veritable platform for all Nigerians to participate in active governance, irrespective of their Social and Economic strata.
- 8 Mobilize Nigerians for effective harnessing of her

JMPP shall revive several moribund but viable Bilateral Agreements and Memoranda of Understanding (MoU) and negotiate new ones with many Countries, including Italy, Brazil, Switzerland, Austria and Australia, among others. These agreements shall include Investment Promotion and Protection Agreements (IPPAs), Avoidance of Double Taxation Agreement, Agreement on Abolition of Visas for Holders of Diplomatic and Official Passports and Bilateral Air Services Agreements (BASA), among others.

In addition, JMPP shall strengthen the Country's Diplomatic Capacity, as well as, encourage the establishment of Bi-national Commissions with several Countries with huge potential for investment capital, transfer of skills and technology into her economy. JMPP shall deploy all efforts at closing the existing gap in trade between Nigeria and her overseas partners.

#### P Oath of Commitment

In order to build a democratic Nigeria, and enthrone accountable and transparent governance, JMPP shall ensure the following:

- 1 That every Member shall swear to an Oath to uphold Honesty, Decency and Credibility in all his/her Public Conducts.
- 2 To consider Nigeria, his/her State, and Local Government before self in that order, in all his/her Public Conducts.
- **3** To shun corruption and corrupt practices in all his/her Public Conducts.
- 4 To uphold ethical conduct in all his/her Public Conducts.

very seriously. While we will discharge this essential function of extending Consular Assistance to Nigerians in need or in distress abroad, all Nigerians living abroad shall be required to remain good Ambassadors of the Country, and also respect the laws and sensitivities of their host.

JMPP's Strategic Action Plan for Multilateral Engagements in Partnership with Institutions, such as, the Economic Commission Of West African States [ECOWAS], the African Union Commission and the United Nations Organization, shall consist of deliberate efforts to lead the process of entrenching sustainable Democracy in Africa. These shall include uncompromising adherence to democratic tenets and values, good governance and human rights, among others. Our stance is anchored on the firm belief that a stable and democratic Africa is in Nigeria's National interest. Consequently, Nigeria would continue to play an active role as a permanent member of the AU Peace and Security Council and also globally.

Nigeria's relations with all Countries in the world shall remain generally cordial and warm. Nevertheless, there are Countries with which Nigeria has deep, traditional-ties, dating back to the colonial days. Relations with the UK, France, United States, Germany and the European Union would be deepened. JMPP shall also deepen relations with emerging market economies such as Brazil, Russia, India, China and South Africa (BRICS) and others in this category. Our objectives are to intensify South-South cooperation and diversify Nigeria's relations in a manner that is consistent with our development aspirations. In this regard, economic cooperation and partnership in project financing and execution, especially, in infrastructure, such as, Power, Health and Railways, among others, would drive the process of our collaboration and engagements. natural, human and material resources.

Additionally, Nigeria's Foreign Policy thrust shall include organizing and engaging Nigerians in the Diaspora. Our Policy shall also include promoting the welfare of Nigerians abroad, to be sure that they are treated with dignity and respect in all circumstances while also ensuring that they do not constitute liabilities to their host communities abroad.

JMPP's intention is to build on existing bilateral and multilateral relations and to promote new partnerships and collaborative initiatives centred on issues that are germane to Nigeria's National interest and in tandem with the JMPP's Developmental Goals.

Threats to National Security – insurgencies and sponsored terrorism all have international dimensions. To strengthen the efforts of our Security Forces, JMPP would reinforce and deepen existing cooperation between Nigeria and her neighbours in the Fight Against Insurgency and terrorism. Improved and reliable exchange of information and intelligence, including Transborder Military Operations, would certainly yield greater results.

JMPP would deploy Diplomacy and Foreign Policy and demonstrate to the world our commitment to maintaining Nigeria's status as the preferred destination for Foreign Direct Investment in Africa. We would demonstrate to the world, our resolve to create the best enabling environment characterized by an apparent ease of doing business in Nigeria.

Nigerians are aware that their welfare forms the principal part of the rationale for maintaining Diplomatic Missions abroad. This is why JMPP shall take Nigeria's Consular Responsibilities

#### N Corruption

JMPP Government will immediately implement the Provision of Section 15 subsection 5 ins Chapter 2 of the 1999 Constitution as amended which expressly provides that "The State shall abolish all corrupt practices and abuse of power". This will be achieved through the following Policies:

1 Promote and sustain the War Against Corruption at all levels of governance through absolute respect for the Rule of Law.

#### **O** FOREIGN POLICY

Under the JMPP administration, Nigeria would be repositioned to ensure effective delivery of the Foreign Policy that must impact more directly on welfare of Nigerians. As Nigeria integrates deeper into the globalizing world, JMPP has correctly identified that every aspect of the well-being of Nigeria has a Foreign Policy component.

JNPP shall have the economic and social well being of the Nigerian citizen at the centre of Nigeria's Foreign Policy at the Sub-Regional, Regional and Global levels.

Emphasis would be placed on Economic Diplomacy, that would encourages partnerships between relevant Ministries, Agencies and Departments (MDAs) and other partners in order to attract Foreign Direct Investment FDI, acquisition of modern skills and technology for the realization of the core objectives of the Party, especially, the construction of infrastructure such as roads, railways, airports, the power and energy sectors. System capable of producing high caliber and patriotic manpower for the Country.

- 2 To provide free and compulsory Primary and Secondary Education for all citizens.
- **3** To rehabilitate, revitalize and promote Vocational and Technical Education in Nigeria.
- 4 To promote Entrepreneurship and Innovative Education in the Country.
- 5 To rehabilitate Universities and other higher Institutions of learning and make them more responsive to Nigeria's development needs.
- **6** To build and promote specialist Universities and Research Institutes in order to facilitate the industrialization of the Country.
- 7 To bridge the gap between university products and technical skills for industrial development through **sector-specific**-practical training.
- 8 To train and re-train Teachers in order to keep them abreast of global trends in science and technology.
- **9** To establish and promote Exchange Programmes between Nigerian University Students and Staff and their foreign counterparts.

#### C Industrialization

In line with the provisions of the 1999 Constitution, which states that the State shall "harness the resources of the Nation and promote National Prosperity and an efficient, dynamic and selfreliant economy;" a JMPP Government shall diversify the economy. This will entail massive investment in Agriculture, Industry, Mining, Tourism, among others.

 $1\,$  JMPP shall strive to encourage and achieve local

production of most products needed for domestic consumption through investment into research in Science and Technology.

- 2 JMPP will ensure massive investment in the Steel Industry through Public- Private Partnership.
- **3** JMPP shall revitalize other areas of Industry where Nigeria has Comparative Advantage.
- 4 JMPP shall facilitate a planned and balanced/even Economic Development for the Country.

#### D Economy:

Section 16 subsection 2 (c) of Chapter 2 of the 1999 Constitution, states that the State shall direct its policy towards ensuring "that the economic system is not operated in such manner as to permit the concentration of wealth or the means of production and exchange in the hands of a few individuals or of a group". In order to provide the resources required to build a more equitable society, JMPP shall faithfully implement this provision of the Constitution through:

- 1 Effective harnessing of Human and Material Resources of the Country for improved living standard of the Citizens.
- 2 Adoption of a mixed economy anchored on Egalitarianism, Social Justice and Free Market Enterprise.
- **3** Introduction of Progressive Tax System that promotes accountable and transparent Government.
- 4 Diversification of the economy with emphasis on manufacturing and export promotion through the instrumentality of Innovation, Creativity and technology.
- 5 Rural Industrialization of the Country through Small and Medium Enterprises (SMEs), Community Based

The JMPP shall pursue the following:

- 1 Promotion of investments in Oceanliners, large and Small Boats to enhance movement of passengers and sustainable fishing as well as international trade.
- 2 To effectively implement the Cabotage Law.

#### L Employment

To stem and reverse rising unemployment, JMPP Government will implement all the Provisions of Section 17, subsection 3 (a - g) under Chapter 2 of the 1999 Constitution. Additionally JMPP Government will strive to achieve the following:

- 1 Massive investment in the expansion of Infrastructural Facilities and Productive Capacity aimed at mopping up unemployment.
- 2 Creation of decent, well-paid jobs with good Conditions of Service and Trade Union Rights.

**3** Introduction of Social Safety Nets to cater for the sick, unemployed and the elderly.

4 Implement a National minimum wage scheme in all Sectors, to be reviewed upward periodically as decided.

#### M Civil Rights

- 1 Promotion of fundamental Human Rights as enshrined in the Constitution of Federal Republic of Nigeria.
- 2 Encouragement of sensitivity in governance of the Country by all in position of authority.
- **3** Freedom of Expression, Worship, Association and Assembly.
- 4 Promote of Multi-Party Democracy that guarantees the right of every Individual and Groups to organize themselves into Political Parties.

#### i Road Transport:

a Construction and modernization of Roads throughout the Federation.

#### b Investment in Public Road.

c Massive building and maintenance of Communities, Villages, Towns and Cities Link Roads.

#### ii Rail Transport

Rail Transport is key to Industrialization because of its capacity to move large volumes of goods and services from one location to another. Modern Rail Transport is faster than Road and more efficient in densely populated Cities. JMPP shall pursue the following Policies and Program on Rail Transport:

1 Modernizing the present Rail Network and connecting strategic parts of the Country.

**2** Encouraging Public-Private Partnership in Rail Transport.

#### iii Air Transport

- 1 To provide functional and modern facilities for efficient and safe air travel.
- 2 To channel massive Public Investments towards the improvement of the Airport facilities across the Country.
- 3 Provide and sustain measures that guarantee safe-air travel and a viable Aviation Sector.

#### iv Water transport

Water Transportation is necessary for conveyance of Goods and Services in Riverine Communities and in International Waters. Organizations, NGOs and CSO's among others.

- 6 Embarking on public works programmes to build Roads, Houses, Railways, Schools and Hospitals in order to create jobs and develop Public Infrastructures.
- 7 To adopt and implement a model economy aimed at projecting Nigeria status as the biggest economy in Africa.
- 8 Making the interests of Nigerian citizens the primary determinant of Government Economic Policies through popular participation of citizens in policy formulation and programme development.

#### E Agriculture:

1 To promote farming and other Agricultural Practices in order to attain food self-sufficiency and food security.

**2** To diversify Agriculture and boost exportation of primary and processed products.

- **3** To boost local production of Organic Fertilizer in order to replace in-Organic Fertilizers known to be harmful to humans and the soil.
- 4 To promote the building and rehabilitation of Plantations, Farm Settlements and other schemes to encourage the Youths to get involved in farming.

**5** To revitalize bank of Agriculture for effectiveness in financing Agricultural businesses.

**6** To encourage processing and acceptable packaging of Agricultural Products for export.

#### F Electricity

**1** To improve power generation in other to ensure regular supply of electricity.

- **2** To fast-track Public-Private Partnership in order to improve Rural Electrification throughout the Country.
- **3** To invest in environment friendly, renewable energy generation and distribution.

#### G Security:

- 1 To provide free, challenging, safe and secure environment for all citizens through the instrumentality of improved Social Welfare Schemes and Community Policing.
- 2 To provide decent accommodation and a living wage for the Police, Military and other Security Personnel as part of the Fight Against Corruption.
- **3** To build the capacity of the Security and Intelligence Community to maintain Peace and Tranquility across the Country.
- **4** To give a pride of place to our Traditional Institution as veritable tools for Peace Building at the Community level.

#### H Culture & Tourism:

- 1 To uphold unity in diversity of Nigeria as well as the sanctity of our diverse ethos and maze ways.
- 2 To harness the Tourism Potentials of the Country and establish Nigeria as an attractive hub of the Continent.
- 3 To uphold Morality, Human Dignity and Integrity.

#### I Entertainment:

- **1** To promote the Entertainment Industry and make it a major Foreign Exchange earner.
- 2 To promote and support Sporting Activities as a strategic and active engagement for our Youths and Children.

#### **ENVIRONMENT**

In accordance with the provisions of Section 20 of Chapter 2 of the 1999 Constitution, which, says that 'The State shall protect and improve the environment and safeguard the water, air and land, forest and wildlife of Nigeria", the JMPP as an environmentfriendly Party will ensure that no project will be undertaken without conducting a comprehensive and genuine environmental impact assessment. JMPP will ensure:

- 1 The provision of adequate and efficient Drainage System to prevent flooding.
- 2 The development of a Housing Policy that guarantees affordable and decent housing for all.
- **3** Investment in Research and Technology leading to mitigation of effects of climate change as well as its adaptation.
- 4 To reclaim and remediate polluted environment especially in the Niger-Delta.
- 5 Development of Policies to confront the challenges of Desertification and Deforestation.
- 6 Develop strategic and maximum utilization of Natural Gas and termination of Gas Flaring.

**7** To implement environmental Policies that promote Safety and Food Security in the Country.

#### K Transportation

In line with Section 15 subsection 3 (a) which stipulates that it shall be the duty of the State to "provide adequate facilities to encourage free mobility of people, goods and services throughout the Federation, JMPP shall pursue the following Policies and Programmes on:
